List the specific section(s) of the Longmont Fair Campaign Practices Act allegedly violated with a description of the violation(s) (*attach extra pages as necessary*):

There is no accounting for the expenditure or in-kind contribution in the 10/13, 10/16, or 10/20 Elect Kaye Fissinger campaign reports for a large billboard that has been driven around Longmont that bears Ms. Fissingers likeness, name, and electioneering information (Vote For Kaye Fissinger). In addition, the added expense of the use of the vehicle and fuel must be accounted for. This is not a yard sign, it's approximately 10' x 20' and can only be displayed on a stationary or moving vehicle.

This has been seen around Longmont since at least 10/8/09 at the Candidate forum at Silvercreek High School, and is still in use at this date.

2.04.211(C)5 Failing to disclose a contribution or expenditure - \$100 per day for each violation, for up to 10 days.

It has been displayed for over 10 days and should be subject to the maximum \$1,000 fine. The expenditure or in-kind contribution of the use of the vehicle and fuel is a separate infraction of over 10 days equaling an additional \$1,000 fine.

Re: Alleged violations of the LFCPA, submitted to the City Clerk by Mr. Richard Yale.

The allegation claims “no accounting for the expenditure or in-kind contribution in the 10/13, 10/16 or 10/20 Elect Kaye Fissinger campaign reports for a large billboard that has been driven around Longmont.....”

The attached documents are copied from the Period One ‘Report of Contributions and Expenditures.’

- 1) Schedule B, page 1 of 4 Item – Printing by Mercury LDO \$7.38
- 2) Schedule B, page 3 of 4. Item – Masonite panels (materials) from Lowe’s \$42.26
- 3) Photocopy of receipts that verify both expenditures were reported.

The “billboard” cited by Mr. Yale is a 4’x 8’ masonite panel with a photo and text message glued to it. One panel is attached to each side of the vehicle. Mr. Yale refers to the panel as a “10’x 20’ billboard.”

The vehicle with panels attached has not “been driven around Longmont.” It has been parked in various places where the vehicle is used in the regular course of daily activities. The panels are attached after the vehicle is parked.

The expenditure for the panels was properly reported, and the cost of driving the vehicle to different locations is covered in LFCPA 2.04.20~~3~~ “services provided by individuals volunteering their time on behalf of a candidate or committee.” The cost of driving the vehicle is neither a contribution to nor an expenditure of the campaign.
