



1 Satisfaction of the submittal requirements of Appendix B to Title 15 of the Longmont  
2 Municipal Code, including transfer of historic water rights, and submittal of two mylars of the  
3 signed annexation map, and payment of the recording fees.

4 After satisfaction of the requirements as certified by the Planning Director of the City of  
5 Longmont, the City Clerk shall record this ordinance, the annexation map(s) and annexation  
6 agreement with the County Clerk and Recorder.

7 Section 3

8 Pursuant to Section 37-45-136(3.6), C.R.S., the City of Longmont consents to the  
9 inclusion of the property into the Municipal Subdistrict, Northern Colorado Water Conservancy  
10 District, when the annexation becomes effective.

11 Section 4

12 The effective date of this annexation shall be the date this ordinance, the annexation  
13 map(s), and the annexation agreement are recorded with the County Clerk and Recorder.

14 Section 5

15 To the extent only that they conflict with this ordinance, the Council repeals any  
16 conflicting ordinances or parts of ordinances.
