13 conflicting ordinances or parts of ordinances.

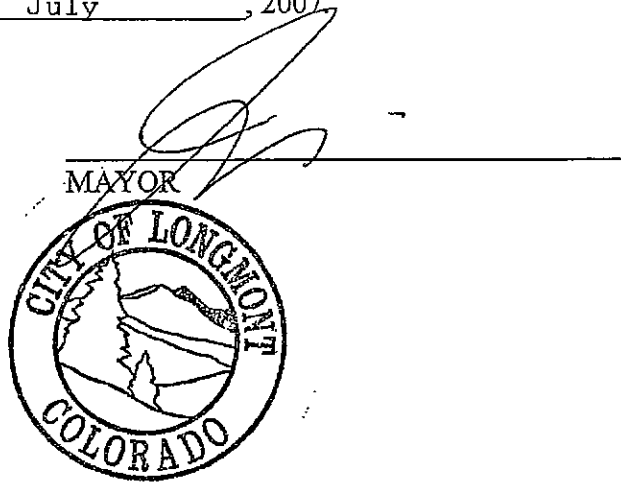

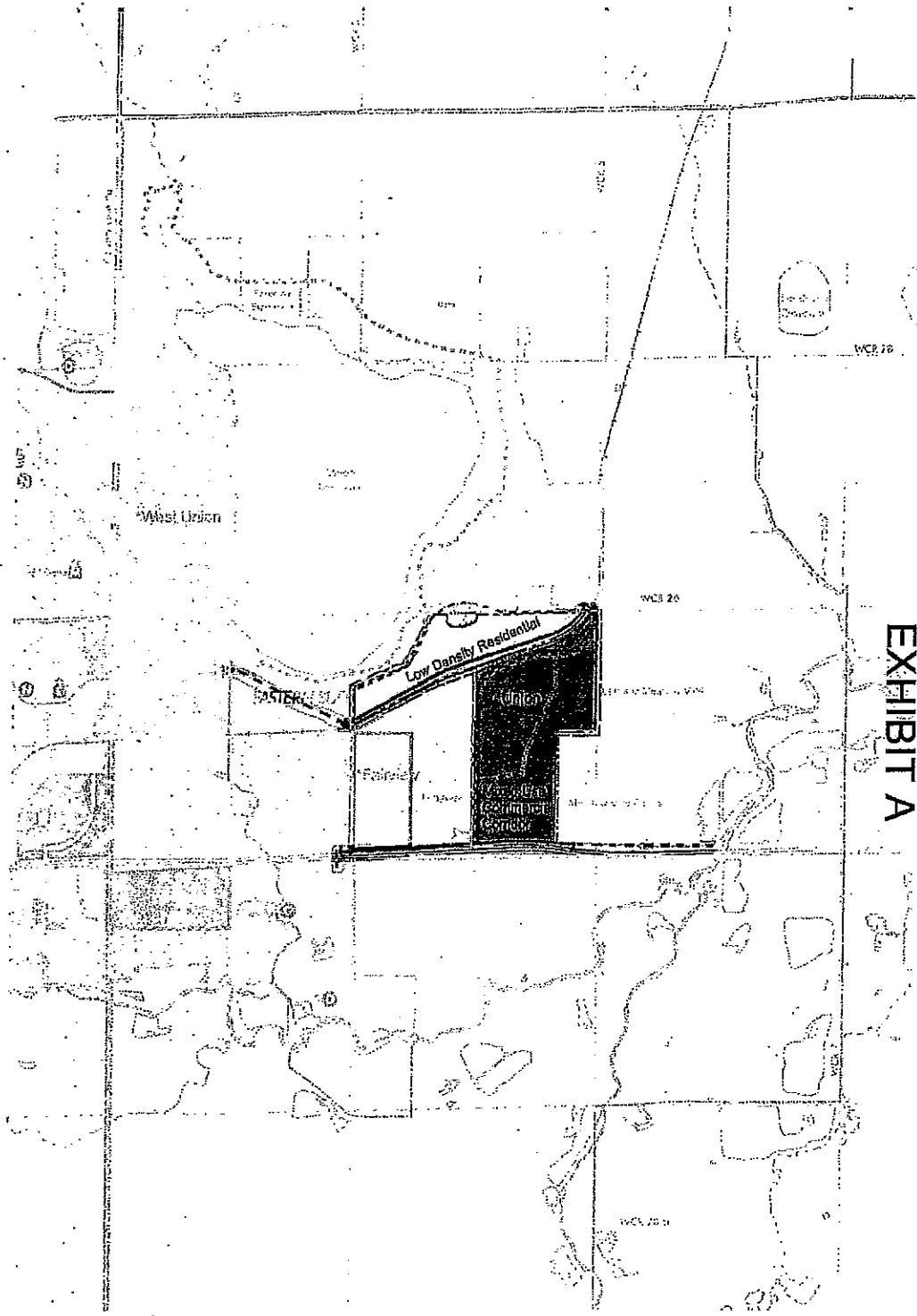
