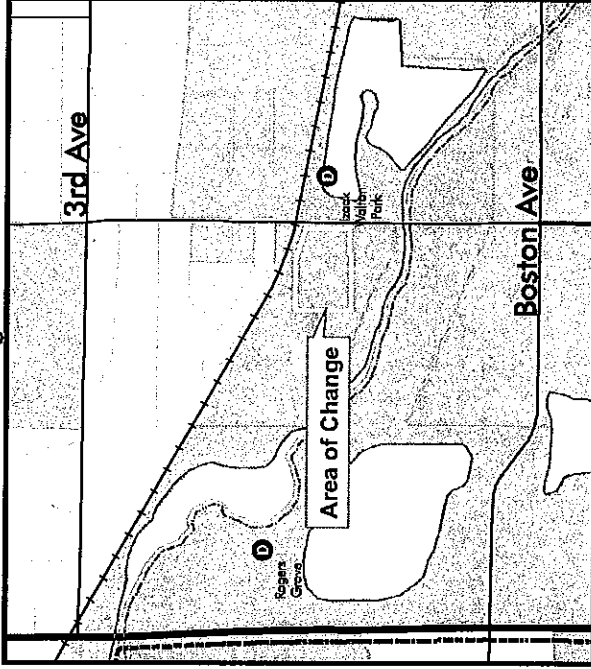

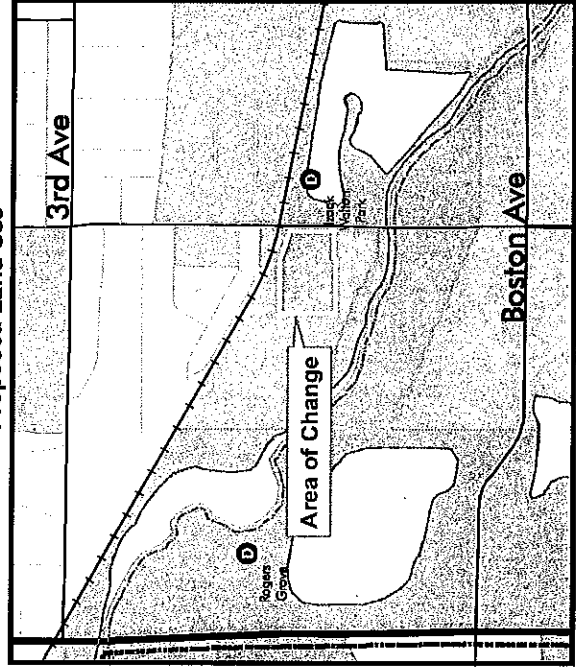

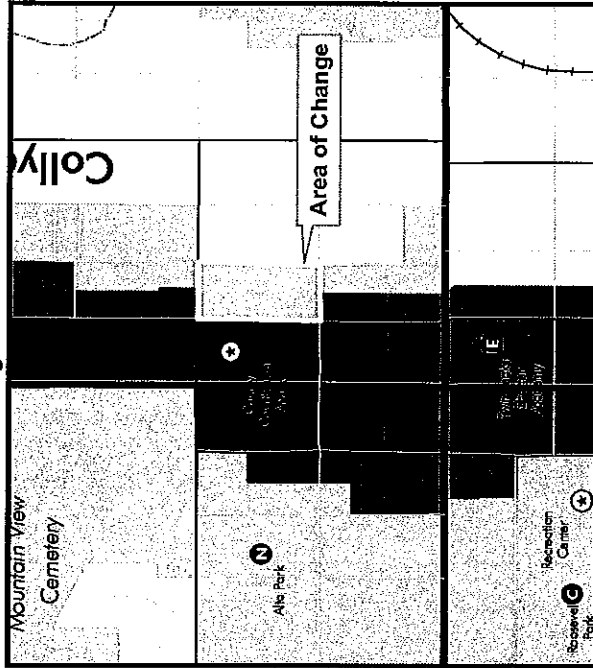
Parks Maintenance Facility Existing Land Use



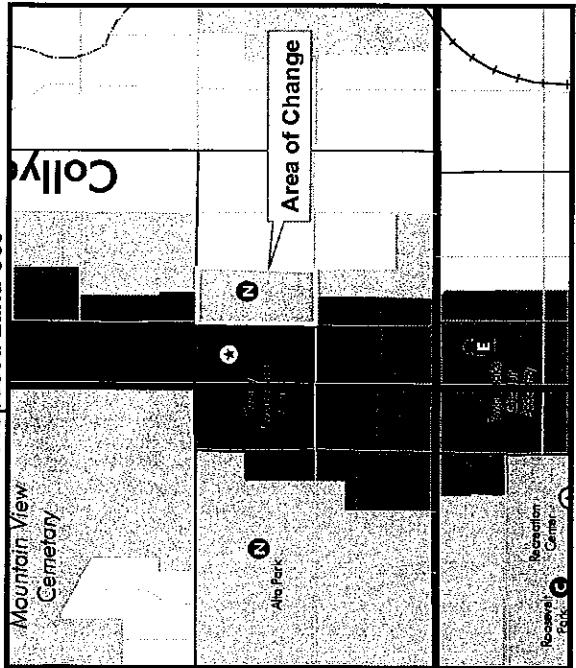
Proposed Land Use
