When all sections have been filled in, please return this completed form to the City of Longmont, Public Works Division.
- If the improvements required for Construction Acceptance are found to be incomplete, the developer shall follow the same process as specified in the Construction Acceptance Brochure and request another inspection. The City may require additional inspection fees for subsequent inspections.
- In accordance with the Public Improvement Agreement, the Developer is responsible for the maintenance of public improvements for a minimum of 1 year after Construction Acceptance is granted or until Final Acceptance has been granted by City Council.
