Terms and Conditions of City of Longmont Recreation Services
Monthly Auto Pay Pass

All pass holders agree to follow the City of Longmont facility rules and regulations. Failure to follow the rules and regulations may result in termination of their monthly pass and Recreation facility privileges.

This facility is not responsible for loss of any personal belongings. Pass holder assumes all risk of damages resulting from accidents or injuries sustained at this facility.

It is understood that completing this monthly pass payment agreement constitutes a contractual commitment to pay Recreation Services fees on a monthly basis. The monthly auto pay pass is

non-transferable. Failure to use the Recreation facilities will not relieve the member of the obligation to pay monthly fees.

I understand that it is my responsibility to update my customer information (i.e. address, phone number, credit card number) in the event my information changes.

All monthly pass payment fees will be automatically charged to the pass holder's credit card, as authorized by the pass holder. If in the case your credit card is declined your pass will be put on hold until payment is received. If you have questions about your pass or changes to your personal information, please notify Cathy Diesing, Recreation Services at 303-774-4756.

The Recreation Services Division reserves the right to cancel this agreement at any time it deems that the conduct of the pass holder is detrimental to the Recreation Services Division and/or contrary to its regulations. In the event of a cancellation of a pass by the Recreation Services Division, all future payments due under the contract shall be waived, and any advance payments refunded.

I hereby, for myself, my child, my heirs, executors and administrators, waive and release any and all rights and claims for damages I or my child may have against the City of Longmont and its employees, representatives, successors and assigns for any and all injuries suffered by myself or my child. I understand that photographs may be taken by the City of Longmont. I grant the City of Longmont permission to use my likeness, and/or my child(ren), in any and all publications and in any and all other media now and in the future.
